

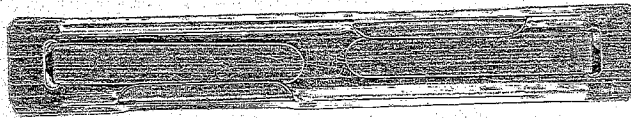


Dear Patron:

The Pueblo Lands Board, constituted under the Act of Congress approved June 7, 1924, hereby reports under Section 8 of said Act, as follows:

The Board recommends the purchase of the certain tracts of land and buildings, title to which it has found extinguished, situated in and adjacent to the plaza of the Pueblo village, in order to consolidate the Indian ownership in the said pueblo, as follows:
